



PRIVACY POLICY

The Privacy Policy (hereinafter referred to as the “Policy”) applies to all information about you, which the NGO “Research Center of Economic and Legal Solutions in the Area of Application of Distributed Ledger Technologies” (registration number: 43370506) (hereinafter referred to as the “Developer”) can obtain when you use the functionality of the official website of the Research Center <https://www.blockchainukraine.org/>.

This Policy is prepared in accordance with the Regulation (EU) 2016/679 “General Data Protection Regulation” (GDPR), Directive 2009/136/EU and Directive 2002/58/EU “Privacy and Electronic Communications” (ePrivacy Directive).

This Policy provides you with information on what type of Personal Data is collected while you use the functionality of the official website of the Research Center, why it is collected and how it is processed. Within the scope of the Policy, you are a Personal Data Subject.

We recommend that you read and accept the terms and conditions of the Policy before using the functionality of the official website of the Research Center.

1. TERMS AND DEFINITIONS

1.1. Terms used in this Policy shall be interpreted in accordance with the following definitions:

1.1.1. **Developer** is the NGO “Research Center of Economic and Legal Solutions in the Area of Application of Distributed Ledger Technologies” (registration number: 43370506) that develops and maintains the functioning of the official website of the Research Center <https://www.blockchainukraine.org/>, as well as performs the Personal Data Processing.

1.1.2. **Personal Data** is any information directly or indirectly related to a Personal Data Subject. In accordance with GDPR, Personal Data of a Personal Data Subject shall be:

- full name;
- date and place of birth;
- address of permanent and temporary residence;
- mobile phone number;
- information about family and social status;
- information about education, profession and occupied position;
- information about income and financial situation;
- biometric data;
- cookies (along with other Personal Data), etc.

1.1.3. **Processing of Personal Data** is any action (operation) or a set of actions (operations) with Personal Data using automation tools or without using such tools, including collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (distribution, provision, access), anonymization, blocking, deletion, destruction of Personal Data and other actions.

1.1.4. **Confidentiality of Personal Data** is a requirement to prevent distribution of Personal Data without the consent of the Personal Data Subject or without any other legal grounds binding upon the Developer.

1.1.5. **Personal Data Subject** is any natural person, whose Personal Data is subject to processing.

2. GENERAL PROVISIONS

2.1. This Policy shall apply to legal relations that arise out of the use of the functionality of the official website of the Research Center.

2.2. If you do not agree to the terms of the Policy, the Developer will not be able to Process your Personal Data, which will result in restriction of your use of the functionality of the official website of the Research Center.



- 2.3.** The Policy can receive amendments through publication of the updated Policy on the official website of the Research Center. The amendments shall be deemed accepted the first time you use the functionality of the official website of the Research Center after the updated Policy is published. If you do not agree with any changes, the only way of protecting yourself from unauthorized Processing of Personal Data is to stop using the functionality of the official website of the Research Center.
- 2.4.** The Developer has no control over and shall not be responsible for the privacy practices of third-party resources. If you accept a privacy policy on a third-party resource, it shall not mean that you accept this Policy and vice versa. The Developer has no control over and shall not be responsible for third-party resources that can be visited by clicking the links available on the official website of the Research Center.

3. SCOPE OF THE PRIVACY POLICY

- 3.1.** The Policy establishes the Developer's non-disclosure obligations and ensures Confidentiality of Personal Data.
- 3.2.** The Developer can obtain your Personal Data when you use the functionality of the official website of the Research Center, in particular to become a member of the NGO "Research Center of Economic and Legal Solutions in the Area of Application of Distributed Ledger Technologies" (registration number: 43370506). This Personal Data includes:
- full name;
 - telephone number;
 - e-mail;
 - your passport copy;
 - occupied position;
 - academic degree, academic rank, national awards, titles of honor;
 - involvement in projects, consulting;
 - experience in public activities;
 - country of citizenship;
 - correspondence address;
 - your signature scanned copy.
- 3.3.** The data obtained through automatic collection is considered analytical (statistical) and is not the data identifying a certain Personal Data Subject.
- 3.4.** The Developer can obtain the following data through automatic collection:
- IP addresses accessing the official website of the research Center;
 - information from cookies (a small piece of data sent by a web server and stored on your computer, which is sent to the web server in an HTTP request each time you try



to open the page of the corresponding website);

- information about browser;
- time of use;
- referrer (address of the previous page);
- information related to how you interact with the official website of the Research Center.

4. PURPOSES OF COLLECTING PERSONAL DATA

4.1. Personal Data is collected in order to:

- provide membership in the NGO “Research Center of Economic and Legal Solutions in the Area of Application of Distributed Ledger Technologies” (registration number: 43370506);
- optimize the operation of the official website of the Research Center;
- protect against automated attacks and abuses/hacks;
- improve the data collection, storage and processing methods to prevent unauthorized access to the official website of the Research Center;
- measure the performance of the official website of the Research Center;
- save settings and session (use of the website or app) data for further use;
- analyze your use of the functionality of the official website of the Research Center;
- provide effective customer and information support should any issues related to the use of the official website of the Research Center arise;
- provide feedback, including sending notifications and requests regarding the use of the functionality of the official website of the Research Center, services, processing your requests and applications;
- provide updates, special offers, information, newsletters, etc.;
- monitor activity when using the functionality of the official website of the Research Center.

4.2. All collected Personal Data shall be used for the specific above-mentioned purposes and only to the extent necessary for the full functioning of the official website of the Research Center.

5. METHODS FOR COLLECTING AND PROCESSING PERSONAL DATA

5.1. You are hereby notified that when you use the functionality of the official website of the Research Center, the Developer can obtain data about the applications installed on the device and use this data to implement certain features of the official website of the Research Center.



- 5.2. The Developer may send you a request for provision of Personal Data or for permission to process already available Personal Data.
- 5.3. The official website of the Research Center uses protection tools to ensure security of your Personal Data. When servicing the official website of the Research Center, the Developer receives information that allows detecting and automatically eliminating the components that pose a potential security threat to the official website of the Research Center.
- 5.4. The Developer uses a number of processes/methods for protecting the official website of the Research Center from unauthorized attempts to access, modify, disclose or destroy data.
- 5.5. The official website of the Research Center can use third-party services that may collect your Personal Data. You can receive the up-to-date information on third-party service providers used on the official website of the Research Center through the feedback form on the official website of the Research Center by submitting the relevant request.
- 5.6. The Developer is entitled to transfer your Personal Data to third-party services (third parties) in order to:
 - optimize the operation of the official website of the Research Center;
 - render services related to the maintenance of the official website of the Research Center.
- 5.7. Your Personal Data may be transferred to the authorized state authorities and/or competent organizations only on the basis and in the manner established by international laws and the laws of the country you are a resident of.
- 5.8. Personal Data is provided to third-party services in accordance with the existing confidentiality requirements for the specific above-mentioned purposes, and only to the extent necessary for the full functioning of the official website of the Research Center.

6. DEVELOPER CONTACTS

- 6.1. Messages or requests are sent to your actual residence address, e-mail address, telephone number or using any other means of communication you specified.
- 6.2. You can contact the Developer by e-mail: info@blockchainukraine.org.

7. GENERAL CONDITIONS

- 7.1. Only the Developer shall make any changes and/or additions to this Policy.
- 7.2. In case of any differences between various versions (written, printed, electronic, etc.) of this Policy, the electronic version currently available on the official website of the Research Center shall prevail.
